



What is AVEO ACE?

AVEO ACE (Access Center of Excellence) is a comprehensive program dedicated to providing personalized support throughout the FOTIVDA treatment journey.

Insurance Coverage Support*

Benefits Investigation

AVEO ACE will determine your eligibility and coverage for FOTIVDA.

Prior Authorization and Appeals Support

AVEO ACE is your advocate during the prior authorization (PA) and appeals process, and will work with your provider's office to help you access FOTIVDA.

Pharmacy Coordination

AVEO ACE will triage the prescription to your preferred network pharmacy or in-office dispensing location.



Financial Assistance[†]

Co-Pay Support

Patients with commercial or private insurance may be eligible to enroll in the AVEO ACE Co-Pay Assistance Program. If approved, you could pay as little as \$0 for FOTIVDA.†

Patient Assistance Program

Patients who are uninsured or underinsured may qualify to receive FOTIVDA free of charge through the AVEO ACE Patient Assistance Program.



Coverage Delays or Interruptions[‡]

Quick Start Program

Provides free FOTIVDA to eligible patients who experience a payer decision delay of 5 business days or more.

Bridge Program

Provides free FOTIVDA to eligible patients who experience coverage interruptions while already on treatment.



Ongoing Education and Support

Nurse Support Program

The AVEO ACE Program offers a personalized Nurse Support Program that provides:

- General education on FOTIVDA treatment and what to expect while on treatment
- Resources to support you and your caregivers during your treatment journey

AVEO ACE FAQs

Coverage and Access Assistance:

How will I know if my FOTIVDA prescription is covered by my insurance?

Your dedicated ACE Program Specialist will help you understand your insurance coverage. They will work with your healthcare provider (HCP) to navigate any prior authorizations (PA) or appeals and will help identify financial support programs that might be available to you.

What can I do if I receive a denial of coverage?

Commonly, specialty medications require a PA which is a verification from your HCP that explains that the prescribed medication is medically necessary to treat your condition. If your PA is denied, your ACE Program Specialist will work with your HCP to support the appeal process, while keeping you informed every step of the way.

What if my physician wants me to start medication right away?

Once enrolled with ACE, you may be eligible for our AVEO ACE Quick Start Program, which provides medication to patients at no cost if there is a delay in obtaining FOTIVDA coverage. Your ACE Program Specialist can check if you are eligible for the Quick Start Program.

If coverage is obtained, how will I receive the medication?

Covered patients can access FOTIVDA through one of our limited distribution specialty pharmacies or through in-office dispensing when available. Your ACE Program Specialist can help ensure your prescription is sent to the appropriate pharmacy for processing.

Cost and Financial Support

Commercial Insurance:

Patients with commercial or private insurance may be eligible to enroll in the AVEO ACE Co-Pay Assistance Program, which allows eligible patients to pay as little as \$0 for their FOTIVDA prescription.*

Medicare or Government Insurance:

While patients with government insurance are not eligible for the Co-Pay Assistance Program, your ACE Program Specialist will assist in identifying financial support that may be available from independent charitable foundations.[†]

 Medicare Extra Help: Some patients enrolled in a Medicare Part D plan may be eligible for extra help, which may lower the cost of your prescription drugs. Your ACE Program Specialist can check if you are eligible and guide you on how to apply through this link.

Uninsured:

If you do not have insurance coverage or have been denied coverage, your ACE Program Specialist can check your eligibility to receive FOTIVDA for free through the AVEO ACE Patient Assistance Program.[‡]
